


### Annual Meeting Notice

Hasbro, Inc.'s Annual Meeting of Shareholders will be held on May 19, 2016 at 1027 Newport Avenue, Pawtucket, Rhode Island, at 11:00 a.m. Eastern Daylight Time.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends you vote FOR all nominees and FOR Proposals 2 and 3.

Three matters are scheduled to be voted on at the 2016 Annual Meeting. Those three proposals are:

- 1. The election of the following twelve (12) persons as Directors to serve until the 2017 Annual Meeting of Shareholders, and until their successors are duly elected and qualified:
  - Basil L. Anderson, Alan R. Batkin, Kenneth A. Bronfin, Michael R. Burns, Crispin H. Davis, Lisa Gersh, Brian D. Goldner, Alan G. Hassenfeld, Tracy A. Leinbach, Edward M. Philip, Richard S. Stoddart and Linda K. Zecher.
- 2. The adoption, on an advisory basis, of a resolution approving the compensation of the Named Executive Officers of Hasbro, Inc., as described in the "Compensation Discussion and Analysis" and "Executive Compensation" sections of the 2016 Proxy Statement.
- 3. Ratification of the selection of KPMG LLP as Hasbro, Inc.'s independent registered public accounting firm for fiscal 2016.
